

**TIS INTEC Group establishes new base in Myanmar:
New Joint Venture in Yangon wins project from Major local bank &
to expand financial solutions**

Tokyo, Japan, September 4, 2017 — TIS Inc., a company under TIS INTEC Group announced a new establishment of Myanmar base by its Thai subsidiary, PromptNow Co., Ltd.

PromptNow, a Thai leading company in financial mobile application development for Banking Financial Services and Insurance (BFSI), has become one of the TIS subsidiaries in May 2016. It provides the cutting-edge solutions for banking and financial institutes and is well-known for its mobile enterprise application development on multiple-platform, including iOS, Android and Windows which has many customers from major banks and nonbanks.
